Consent Table Top Training Event

On the 10th of December 2015, as part of the 16 Days of Action in partnership with Perth and Kinross Violence Against women Partnership, we facilitated a consent training event in Perth Prison.

The event focussed around the Channel 4 docu-drama 'Consent' enabling participants to see first-hand the impact of rape on survivors in terms of reporting and the court process. The event was attended by 40 individuals from statutory and non-statutory agencies including Police, Social Work, Criminal Justice, Education, Youth and Community Development.

The participants had a chance to discuss the key point and issues raised within each chapter of the docu-drama as well as make a final decision on whether the jury would find the accused guilty or not guilty of rape. In addition we welcomed guest speakers from Police Scotland and the Procurator Fiscal explaining their role in the reporting process and prosecution of sexual offences.

We would like to thank Craig Kelly and Esther Bigham from Police Scotland and John Malpass from the Procurator Fiscal for speaking at the event as well as Perth Prison for hosting the event and providing lunch.

Reclaim the Night March – Dundee City

Our Youth Ambassadors, staff and volunteers battled the rain and wind to reclaim the night! The Youth Ambassadors created a wonderful banner and everyone enthusiastically marched around the city centre with lots of other groups and organisations letting everyone know that sexual violence must end!

Our work with Young People in Schools

A 2013 report "Sex without consent, I suppose that is rape": How young people in England understand sexual consent by the Children's Commissioner highlights the key finding as;

- In the main young people understand what is meant by giving consent to sex, but have a very limited sense of what getting consent might involve.
- Young people can describe what consent means in theory but real life contexts make a significant difference to their perceptions of what non-consensual sex looks like.
- The most significant influence on young people's understanding of consent is constructions of gender, particularly of masculinity. All young people referred to the sexual double standard which rewards young men for having sex while passing negative judgment on young women who do so.

These 3 key findings are very much reflected in our work with young people in schools and in youth settings. We feel it is crucial to address these issues and support young people to understand what consent is and how society's gender expectations pressurise young people to behaviour in particular ways, which do not necessarily reflect their own personal feeling and choices.

We address these issues in a number of ways including by delivering a Choices and Consent Session as part of our Prevention Programme in Schools across Perth and Kinross. In the last 12 months we have delivered this session to 5th Year pupils in six schools and two specialist educational centres. The session looks at what consent is, what the law says and how we can all ensure we have consent when involved in any sexual activity.

We believe that by delivering sessions looking at choices and consent we can increase young people's awareness of their rights and responsibilities and work towards a society without sexual violence. Ultimately if everyone respected full consent no one would have to experience sexual violence.

During our work over the last few years we are told time and time again by teachers and youth workers that they feel unable to provide learning sessions to young people about consent, as well as all the issues that surround this topic.

As a result we have developed a resource pack for anyone working with young people to enable them to confidently deliver 5 learning bite sessions about a range of subjects which focus on gender expectations and consent/sexual violence. Each learning bite has learning materials for the teacher/youth worker to explore as part of their learning and building their knowledge before they deliver the session. The learning bites are suitable for a range of ages starting from High School age


